Applicants must:

- Be currently sanctioned by the NDA with an expiration date of August 31, 2010
- Be in good standing with their NDA operator
- Obtain and show proof of a valid passport by April 1, 2010

League requirements:

- *For League and State Tournament applicants*
 - Must have played a minimum of 96 league games with their NDA operator between January 1, 2009 and December 31, 2009
- *For Team Dart applicants*
 - Must meet all Team Dart requirements, including playing a minimum of 96 league games with their NDA operator between April 1, 2009 and March 5, 2010

**Eligibility is contingent on verification of league or tournament participation by your NDA operator, NDA staff or State Dart Tournament representative.*

**NOTE: Applicants do NOT have to be winning teams in league or at a tournament to be eligible for this contest.
The only requirements are noted above.**
