Three ways to win:

- 2) Play in an NDA-Affiliated State Dart Tournament
- 3) Play in Team Dart

Four Doubles Teams will be randomly selected to play in a dart tournament in Europe in the Summer of 2010.

Roundtrip airfare, accommodations and entry fees are included.

Participate in an NDA-Sanctioned Dart League

2 Doubles Teams (4 individuals) will be selected from a 2009 NDA Dart League

Participate in an NDA-Affiliated State Dart Tournament

1 Doubles Team (2 individuals) will be selected from the following 2009 NDA-Affiliated State Dart tournaments: *Florida, Indiana, Illinois, Michigan, Iowa, Wyoming, Minnesota and South Dakota*

Participate in Team Dart

1 Doubles Team (2 individuals) will be selected from 2010 Team Dart entrants

A Doubles Team consists of two NDA-sanctioned individuals from the same NDA operator who are participating in an aforementioned program. A Doubles team does not have to be the same team in league, Team Dart or a State Dart Tournament, but must be from the same NDA operator.

Must Apply by January 1, 2010

Teams must print and complete the application available online and fax or mail to the NDA office. Participation in the aforementioned programs does not automatically enter anyone into the contest.

Winners from 2009 League and 2009 State Dart Tournament participation will be chosen by random drawing on Saturday, January 30, 2010 during the NDA Board of Directors' Meeting in Las Vegas, Nevada.

Winners from 2010 Team Dart entrants will be chosen by random drawing on Monday, March 1, 2010.

Winners will be recognized during the Team Dart XXV Opening Ceremony on Monday, April 19, 2010.

NOTE: Open only to United States and Canadian citizens with a valid passport or eligible to obtain a valid passport before April 1, 2010.



ELIGIBILITY REQUIREMENTS



Open only to United States and Canadian citizens with a valid passport or eligible to obtain a valid passport before April 1, 2010.

APPLICANT ELIGIBILITY REQUIREMENTS*

Applicants must:

- Be currently sanctioned by the NDA with an expiration date of August 31, 2010
- Be in good standing with their NDA operator
- Obtain and show proof of a valid passport by April 1, 2010

League requirements:

For League and State Tournament applicants

- Must have played a minimum of 96 league games with their NDA operator between January 1, 2009 and December 31, 2009

For Team Dart applicants

- Must meet all Team Dart requirements, including playing a minimum of 96 league games with their NDA operator between April 1, 2009 and March 5, 2010

**Eligibility is contingent on verification of league or tournament participation by the NDA operator, NDA staff or State Dart Tournament representative*

NDA OPERATOR ELIGIBILITY REQUIREMENTS

Operators must:

- Be in good standing with the NDA
- Sanction 95% or more of entire league system
- Be accountable for statistics
- Approve team that applies by signing the application
